It is compulsory for one Parent/Guardian to accompany the candidate.

Candidates whose names are displayed in the merit list will receive an Email on their registered Email Id & SMS on registered mobile number on 31st May 2025 with Username & Password which will give access to the College Admission form. The candidate will have to complete the form on <https://sxc.qualcampus.com> using the Username & password by **Sunday 01st June, 2025 upto 12:00 midnight.**

Candidate has to clearly state preferences of **Minor Subject, Open Electives (OE's) and Skill Enhancement Course (SEC)** in the above-mentioned form. Minor Subject, OE's & SEC's will be offered based on merit & availability of the seats.

Candidates who do not submit the form within the above-mentioned date will be allotted the courses in which seats are available by the college.

SUBMIT THE FOLLOWING DOCUMENTS:

- 1. Original Class XII marksheet along with two self attested copies.**
- 2. Only for CBSE Board: Photocopy of the Class XII Examination Hall Ticket.**
- 3. Original & attested copy of Migration Certificate for Other Boards.**
- 4. Copy of Baptism certificate /SWD certificate / Special category certificate for the students who apply and have been admitted under that particular category.**
- 5. Copy of University of Mumbai Pre-Online Registration form.**
- 6. Attested Copy of Leaving Certificate / Transfer Certificate**

PAYMENT OF FEES:

Once the form is verified and documents are submitted, candidates will get payment link along with the username and password on their registered email id. Students can pay the fees using the same link. Please leave the College premises only after receiving the link. If link is not received then approach the admin staff on the same day.

The last date to pay your fees will be **Wednesday, 04th June 2025 (by 4.00 p.m.) failing which the offer of admission will be withdrawn** and no consideration will be allowed.
